The federal government recently announced its plan to close the Onefour Research Station in southeastern Alberta. Onefour is home to at least 23 federally listed species at risk, including such notables as the only known site of Eastern Yellow-bellied Racers in Alberta and the largest of only two Soapweed populations in Canada. Onefour has long been used for livestock grazing research and has been a significant source of information on managing semi-arid native grasslands in the northern Great Plains.

No date has been given for the closure of the Onefour as a research station, however this could occur in as little as 12 months time. Although a small portion of Onefour is federal land, the majority is provincial land under long-term lease to the Canadian government. Once the research station has been closed, the federal government may choose to surrender their lease on the land to the province of Alberta. Under either provincial or federal management, formal protection must be put in place for the conservation of these critical grasslands.

We need your help to convince the federal and provincial governments to designate protection for Onefour as either a National Wildlife Area or provincial Heritage Rangeland Natural Area.
