2021 - 2022 News & Campaigns


After Alberta opened up the mountains to coal mining, AWA hosted Town Hall evenings to discuss coal and ongoing coal developments. AWA launched a campaign against coal mining, challenging the Grassy Mountain Coal Project, encouraging members to support a "no coal" policy and demanding the release of Alberta's Coal Policy Committee Engagement Report.

In response to the proposal to legalize hunt farms, AWA has written to oppose game farming, particularly for the role game farms play in introducing disease to wild populations.



Following the announcement of expansion and modernization of Alberta's irrigation system, AWA worked with other interested parties to contract Ecojustice. AWA is working to learn more about the project, and have highlighted concerns for impacts to aquatic and grasslands ecosystems.
