

Action Alert: Banff People Moving Strategy

On December 5, 2022, Parks Canada released the final <u>report</u> from the Expert Advisory Panel on Moving People Sustainably in the Banff Bow Valley. The report outlines eight strategies to reduce traffic congestion and move people sustainably in Banff. Here are some of AWA's main comments:

 The importance of maintaining ecological integrity is mentioned in the report, but is not a theme that underpins the suggested strategies, despite the fact that ecological integrity is the legislated first priority of Banff National Park. This is abundantly clear in the suggestions to develop gondolas, mobility hubs, and trains without analysis of whether new

 AWA is supportive of the creation of a singular system for transportation, booking, and associated user and visitor experiences, in addition to using pricing tools to incentivize the use of mass transportation.

 The suggestions in the report often don't align with the Banff Management Plan, which indicates that any new developments must not "compromise the scenic splendor for which the park has been inscribed on the World Heritage List, nor the distinctive natural, cultural and wilderness qualities that draw people to Banff".

COP15 Update: Adoption of an International Framework on Biodiversity

Last month, nations from around the world gathered for COP15. Commonly known as the United Nations Biodiversity Conference, the meeting resulted in the adoption of the <u>Kunming-Montreal Global Biodiversity Framework</u>.

Some key points from the framework include:

- Conserve 30% of lands and waters and restore 30% of degraded areas by 2030
- Reduce harmful subsidies by US\$500 billion per year by 2030
- Mobilize US\$ 200 billion for the implementation of biodiversity strategies and action plans
- Reduce loss of high biodiversity areas to near zero by 2030
- Significantly reduce waste generation, pollution, and invasive species introduction
- Encourage and enable businesses to monitor and report impacts on biodiversity

Conservation group opposes oilsands mining project on northern Alberta wetland

An Alberta conservation group is raising concerns about the potential for environmental damage from an approved oilsands mining operation on an important wetland in northern Alberta.

The Alberta Energy Regulator approved Suncor's plan for work in the McClelland Lake Wetland Complex last year. The project is part of the company's current Fort Hills oilsands operation.

Phillip Meintzer, conservation specialist with the AWA, had been trying to get a copy of the letter of authorization for the McClelland Lakeland project for about two months before finally getting one last week.

After reading the letter of authorization, Meintzer is concerned.

"We just don't think that it's possible to ... have a mine in one half and say that there's going to be no impact to the other half," Meintzer said.
